

PRIVACY POLICY

- 1) Liberty Lines S.p.A., based in 5, Via G.S. Vulpitta, Trapani, VAT no. 01920660816, website www.libertylines.it, guarantees that any information collected either manually or automatically will be used in compliance with the Code on the Protection of Personal Data (Legislative Decree 30.6.2003, no. 196 and subsequent amendments) and, where applicable, with the Ministerial Decree 13.10.1999. As the only owner of the data, Liberty Lines S.p.A. recognizes the right to the protection of personal data (art. 1 of the L.D. 196/2003 and subs. mods.) and guarantees its use with respect to the rights, fundamental freedoms and dignity of the interested party, with particular reference to confidentiality, personal identity and the right to the protection of personal data (art. 2).
- 2) Any "sensitive" data (art. 4, para 1, letter d) will be processed in accordance with Authorizations no. 2/2014 and 5/2014 issued by the Guarantor for the Protection of Personal Data. Without prejudice to any legal obligations, Liberty Lines S.p.A. declares it will not save any information regarding navigational data.
- 3) Guaranteeing "minimal" use of personal and identification data (art. 3), Liberty Lines S.p.A. declares, in accordance with art. 11 that: personal data will be processed in a lawful and correct manner; it will be collected and recorded for specific, explicit and legitimate purposes; it will be collected accurately and, where necessary, kept up to date, relevant, complete; it will not be excessive in relation to the purpose for the data; it will be kept in a format that permits the identification of the interested party and for a period of time not exceeding that necessary for the purposes for which it was collected or subsequently processed.
- 4) In accordance with art. 13, Liberty Lines S.p.A. informs interested parties that:
 - the collection and processing of personal data may be made using manual and/or computer means and are intended only for use of the services offered by Liberty Lines S.p.A.;
 - the obligatory or optional nature of the provision of data is specified each time at the time of collection;
 - the refusal to provide personal information indicated as mandatory or refusal to give consent for its use will result in the inability to book services or conclude contracts with Liberty Lines S.p.A., given the resulting impossibility for the latter to materially organize its services and/or ensure efficiency;

- the data collected will not be disclosed to third parties, nor will it be circulated, except to the competent authorities in line with legal requirements, specifically those related to the Ministerial Decree 13.10.1999.
- 4) At any time the interested party may exercise his or her right to access his or her personal data and other rights under art. 7 by making a request to the data controller by letter, fax or e-mail, sent to the company headquarters indicated in (1).
 - 5) In the event of the cessation of its use, for whatever reason, the data collected will be handled in accordance with art. 16.
 - 6) Browsing the website www.libertylines.it does not require the submission of personal information. The optional sending of e-mails to the address **info@libertylines.it** involves the subsequent acquisition of the sender's email address and other data included in the message, in order to deal with any requests. In responding, Liberty Lines S.p.A. will send the interested party the relevant policy on the processing of any personal data contained in the e-mail.
 - 7) In accordance with the General Provision of 8.5.2014 of the Guarantor for the Protection of Personal Data (Official Journal 126 of 3.6.2014), Liberty Lines S.p.A. declares it will not collect, through navigation of the website www.libertylines.it, information on the user or information identifying the computer or browser of the user, through the use of so-called "cookies".
It is specified that the so-called "session cookies" that may be used on the website www.usticalines.it, are only stored temporarily and non-persistently at the user's terminal and consist only in the transmission of session identifiers for the exclusive purpose of facilitating access to the contents of the site, and do not allow for the acquisition of personal data of the user.
